LOS ALAMOS COUNTY VENDOR LICENSE

This license only ensures the Vendors paperwork is in order and allows them to vend at approved venues in Los Alamos County and that the Vendor will pay any additional fees associated with that venue.

NO SALES VENDORS: Do not require a Business License or Vendor License if the materials they are distributing only promotes and markets (no sales) goods, wares and merchandise or goods crafted primarily of manufactured materials and processes and/or made by someone other than the vendor, in the County for no sales.

SALES VENDORS

- **Are required to provide a copy of a current Los Alamos County Business license.** Processing takes a minimum of 5 business days.

- **Are required to obtain a Vendor's License from the Los Alamos County Parks, Recreation, & Open Space Division (LAC PROS).**
Documentation is inspected and verified prior to receiving a Vendor License from the LAC PROS Division.

- **Non-Food:** Any person, business, or organization who offer to sell stocks or samples of goods, wares and merchandise or goods crafted primarily of manufactured materials and processes and/or made by someone other than the vendor.
- **Food Vendors:** Any person, business, or organization who offer for sale, occasionally or temporarily, food products, or samples in the County **are required to provide the County with the following documentation prior to the issuance of a permit:**
 - ◆ **A current NMED Food Permit (Annual or Temporary), a letter on NMED letterhead waiving the requirement for a food permit, or check the box on the Vendor's License that the NMED was contacted and stated that a food permit was not required.** Per the NMED requests and documents must be receive at least 10 days in advance.

 - ◆ **A copy of General Liability Insurance in the amount of \$1,000,000 naming Los Alamos County as an additional insured.**
- **High Risk Vendors** such as but not limited to Caterers, Alcohol, Petting Zoos, and Circuses shall be required to provide the County with the following documentation prior to the issuance of a permit:
 - ◆ **A copy of General Liability Insurance in the amount of \$1,000,000 naming Los Alamos County as an additional insured.**
- **Carnival Rides / Inflatable Games: Per the State of New Mexico Regulation & Licensing Department Carnival Ride Insurance Program** all rides, as described by this program, must be inspected and certified annually. No carnival ride can be operated before being certified by the NM Carnival Ride Insurance Administrator.

 - ◆ **Carnival Ride Insurance Program Certificate Issued by the NM Regulation & Licensing Department**

ADDITIONAL RULES & REGULATIONS FOR ALL VENDORS:

- Once a vendor license is issued it is valid for one year unless the other required paperwork expires before the renewal date.
- Vendors are accepted on a first come first serve basis, when all permits and insurance forms have been submitted and fees have been paid.
- The organizing committee will attempt to place food booths in the best possible locations for the least amount of competition.
- Vendors must complete set-up/unloading by the time specified for each event and are expected to be open for the entire duration of the event.
- **Vehicles may not park on Central Avenue, with the exception of approved food service vehicles/trailers.**
- **NO vehicles are permitted on the grass at Ashley Pond, Fuller Lodge, or any County field/park unless specifically arranged for that event.**
- Vendors must provide their own 10' x 10' tents unless provided by Los Alamos County during some special events.
- **EACH VENDOR IS RESPONSIBLE FOR PICKING UP AND DISPOSING OF THEIR TRASH**
