

## Los Alamos County Fair & Rodeo Queen's Court Contestants Information & Registration Packets

Queen, Princess and Sweetheart candidate(s) must be single, never been married, never had a child and between the ages of Queen (17-25) Princess (14-16) Sweetheart (10-13) years inclusive, as of September 1<sup>st</sup>.

It is understood that when a candidate is named Los Alamos County Fair & Rodeo Queen, Princess or Sweetheart she is to remain single during her reign. If a girl is named Queen, Princess or Sweetheart and marries during her reign, her title is automatically relinquished.

Entry blanks must be completed and signed by the candidate and her parents, and must be submitted to the Los Alamos County Parks, Recreation and Open Space Administrative Offices by **Wednesday, April 10th, 2019 by 5:00pm.** These applications may be turned in at the Aquatic Center in care of the L.A.C. F & R Competition.

A candidate must furnish her own horse; however, the mount may be borrowed.

Candidate must be a Los Alamos County Resident or must attend Los Alamos Public Schools and provide a report card.

If a tie should occur the break will be based on high score for the horsemanship portion of the contest. Decision of the judge(s) is final.

Contest Date: The contest will be held on **Saturday, April 13th, 2019.** The riding portion will begin at 9:00am at the Brewer Arena. The Personality portion of the competition will begin at 12:00pm at the Los Alamos Aquatic Center at 2760 Canyon Rd, Los Alamos, NM.  
(Time subject to change depending on the number of participants)

The contest will be judge accordingly: Horsemanship 60%, Personality 40%.

**Horsemanship** – Each candidate will be expected to perform a designated riding pattern included in the packet. Each candidate will be asked to perform two (2) minutes of free riding time. Please provide a copy of pattern. Western-riding rules will be used in the riding competition. Uniform for the riding competition will be a long sleeved collared plain white shirt, blue denim jeans, western hat and western boots.

Each Candidate must stop in front of the judges and dismount Judge(s) will ask questions and re-mount and exited the arena. Each Candidate will be asked to perform a Queen's run. You will be judged on control of your horse and handling various riding patterns your ability to sit in a saddle; balance, position of hands, feet and seat, as well as, mounting and dismounting. Your understanding of horsemanship skills will be judged not the horse; however, it is certainly recommended that you have your horse and tack clean and ready for competition. Please make sure your equipment is in good working order. Western riding rules, common to ranch horse, rodeo competition and horsemanship will be used in judging.

**Personality** - The Queen's Court speech and modeling section will be held in the Los Alamos Posse Lodge. Contestants will be requested, after they have been announced, to model their outfits, walk the center and introduce themselves by name, and introduce their family if they are present. It is recommended that candidates wear western attire which includes western dress, shirt, pants, long sleeved collared shirt accompanied with a western hat and western boots. The candidate's posture and poise is important. She should have an awareness of fashionable western dress and style with particular attention given to proper style

and color coordination, which enhances her total appearance. The judge(s) will observe a contestant's posture, how she sits, walks and models her outfits, the style she projects and her overall appearance and behavior.

Each Candidate will give a three (3) minute memorized speech about herself on what you are presently doing, your goals, your education and something about Los Alamos County. After the presentations each candidate will be asked to answer a question from the judge(s). These questions will pertain to horse showing and/or rodeos. After the presentations have been completed each candidate will have a personal interview with the judge(s). This interview will last approximately five (5) minutes.

**Behavior** – The Queen's Court is expected to behave in a manner befitting your title. Queen's Court are required to represent the Los Alamos County Fair & Rodeo in a responsible and appropriate manner at all times and all events. Inappropriate behavior is not allowed nor will it be tolerated. Inappropriate behavior may result on the title being pulled with or without warning. The following will be considered inappropriate behavior:

- Swearing, smoking, chewing tobacco, consumption of alcohol or use of controlled substances
- Public displays of affection with a significant other to include kissing, handholding, sitting on laps
- Anger, aggression and/or abuse displayed toward your horse
- Verbal abuse or arguing with anyone
- Unbecoming posts, comments, and photos via text messaging or social networking that reflect poorly on you and the Los Alamos County Fair & Rodeo

**Appearance and Communication** – The Queen's Court will wear the designated attire when representing the Los Alamos County Fair & Rodeo which includes dark western jeans, long sleeved collared shirt, western hat, western boots, crown, sash and belt buckles. You and your horse must always be neat and well groomed. The Queen's Court will not have visible tattoos, face/body piercing or ear gauges. Single ear piercing is excluded. Issues, questions, and concerns should first be directed to the Los Alamos County Recreation Division Staff.

**Crowning** - The Queen's Court will be announced following the personality portion of the competition. Official crowning will be held **Saturday, August 10, 2019** at Brewer Arena before the rodeo. Candidates are required to represent Los Alamos County at the Rio Arriba County Rodeo and Rodeo de Santa Fe. The Sweetheart is only responsible for the Los Alamos County Fair and Rodeo. Any other appearances will be at their own expense. Los Alamos County will pay the entry fee for the State Fair Queen's Competition for the Queen. The Queen's Court candidates will be responsible for all travel, lodging, and food expenses. The Queen's Court should be accompanied by a parent or adult chaperone at all events. Los Alamos County is not required to send staff to the Rio Arriba County Rodeo, Rodeo de Santa Fe, or State Fair Queen's Competition. You may choose to attend other rodeos as time allows. The Queen's Court is required to make several appearances during the Los Alamos County Fair and Rodeo. The Queen's Court is required to wear western attire at all appearances. The Queen is has the option to represent Los Alamos County at the State Fair Queen's Competition.

A stipend will be award to in the following amounts, Queen \$300.00 and Princess \$150.00. The Sweetheart will not receive a stipend. Stipends will not be awarded until the crown and chaps are returned to Los Alamos County.

Los Alamos County will pick a photographer of the County's choice for group and individual photographs of the Los Alamos County Queen's Court.

In consideration of your acceptance of this entry by my signature, intending to be legally bound for myself, my heirs, executors, and administrators, I waive and release any and all rights and claims for damages I may have against the organizers of the County for any and all injuries sustained and suffered by me during this event.

## Queen's Court Contestants

### Queen/Princess/Sweetheart Contestants Horsemanship Pattern

1. Walk through gate, turn left, then right.
2. Pick up the trot as you pass the judges box.
3. Continue to south end.
4. Pick up lope to center of arena – opposite judges box.
5. Do a small figure eight, starting to the right.
6. Do a large figure eight.
7. Continue on to cone and stop and back.
8. Dismount and mount.
