Addendum No. 2

This Addendum No. 2 forms a part of the Solicitation Documents and modifies, as noted below, the original Solicitation Documents identified above.

This Addendum provides to all potential Offerors a link to view the recording of the virtual pre-proposal conference, a correction to the RFP, and questions received and the County's answers:

2. **Page 21, Exhibit A: The following sections of the Sample Services Agreement have been corrected as shown below.**

[FOR CONTRACTS MORE THAN ~~\$200,000.00~~ \$300,000.00] -- WHEREAS, the County Council approved this Agreement at a public meeting held on _____; and

[FOR CONTRACTS MORE THAN ~~\$50,000.00~~ \$100,000.00] -- WHEREAS, the Board of Public Utilities approved this Agreement at a public meeting held on _____; and

3. **Is the County looking for a billing model in the Cost Proposal where the residents are charged directly for door-to-door collections (i.e., resident absorbed) or is the County looking for a billing model where the County is charged for the service (i.e., County absorbed).** Answer: The County requests a County-absorbed billing model in the Cost Proposal where the County is charged for the services, and residents are not directly charged by the Contractor.
4. **Is the County also looking for services to provide onsite household hazardous waste collection services at a specific location or is the County looking for only door-to-door household hazardous waste collection services.** Answer: The County is requesting, door-to-door services in this RFP. The County presently, through a separate contracted service, hosts a monthly Household Hazardous Waste Collection Day at the Los Alamos Eco Station.
5. **We noted that the Pajarito Ski Area (and surrounding community) are in Los Alamos County, so is this area/community included as an area to be serviced under this RFP?**

Answer: At this time, there are currently no residences near the Pajarito Ski Hill area, as indicated on the maps provided with Addendum 1. The County does not currently anticipate that the selected Offeror(s) will service any residences at the Pajarito Ski Hill area. The Los Alamos County Residential Waste, Recycling, and Yard Trimming Route map provided in Addendum 1 shows a clearer picture of where residences are currently located within the Los Alamos Townsite and White Rock and the residential areas that are currently serviced by the Environmental Services Department. The County anticipates that the Contractor(s) would initially, upon the effective date of an agreement with the County, service the same areas noted on that map. However, County reserves the right to modify the residences, routes, and maps provided in Addendum 1 at any time and throughout the term of an agreement.

It is expected that the selected Offeror(s) would provide services to any residents requesting door-to-door household hazardous waste collections anywhere within Los Alamos County. If the fees proposed are based on the areas to be serviced, Offerors should propose scalable or alternate fees that can be adjusted throughout the term of an agreement to allow for changes, increases, or decreases in areas serviced as may be needed and requested by County in the future.

6. **Page 7, Section 7.a.iv. Can you clarify what this program is and under what scenario we might be called to dispose of items through it? “Prepare, request from residents, sign, and provide to County any certification required by law for any materials collected or disposed of by Contractor through the County’s DTD program.”** Answer: The “County’s DTD program” refers to the door-to-door household hazardous waste program that will be implemented with the selected Offeror(s) (i.e., Contractors) awarded an agreement as a result of this RFP. The awarded Contractor(s) will be expected to properly dispose of all materials collected while in performance of services under the agreement and will be required to prepare, sign, and provide to County any certifications required by law to document the proper collection, handling, and disposal of all materials collected by the Contractor.
7. **Can the County provide us with the tons collected each year by type of waste?** Answer: The County is able to provide a report of the volume of HHW collected in 2023 through its Household Hazardous Waste Collection Day events at the Eco Station. The unit measure of weight may vary depending on the type of waste (e.g., G = gallons, LB or P = pounds, etc.). The report is attached to this amendment.

All other provisions of the Solicitation Documents shall remain unchanged. This Addendum No. 2 is hereby made a part of the Solicitation Documents to the same extent as those provisions contained in the original documents and all itemized listings thereof.

Each Respondent is requested to acknowledge receipt of this Addendum No. 2 with the Proposal Forms.
