Addendum No. 2

This Addendum No. 2 forms a part of the Solicitation Documents and modifies, as noted below, the original Solicitation Documents identified above.

This Addendum provides questions received and County's answers to all potential Offerors/Proposers:

1. Section 5.9 of the RFP indicates that our project schedule should "assume a September 1, 2023, project start date". Given this date is already past, what project start date should we assume?

<u>RESPONSE</u>: Assume a September 1, 2024, estimated project start date.

2. In Table 10, the County lists a requirement to "integrate seamlessly with current version of Pictometry." Which Pictometry vendor and version are you currently using?

<u>RESPONSE</u>: The County utilizes the Pictometry web-based product ConnectExplorer. Pictometry hosts the imagery and the software. The County hosts the orthoimagery from Pictometry using ArcGIS Image Server, and the oblique imagery and measurement capabilities are provided through ConnectExplorer.

3. In Table 10, an interface to CountyProtect.com is listed. Is this a CAD or RMS interface?

RESPONSE: This is an RMS Interface.

- 4. We noted a requirement to import citations from TRACS, but also noted an RMS citations export to Full Court (see Table 10). Is this workflow correct? <u>RESPONSE</u>: The workflow is correct.
- 5. Table 6 and Table 9 require a First Due Interface, but Table 8 also lists ESO Firehouse as the current FRMS vendor, with a note about it being replaced. Should both interfaces be included, or just First Due? <u>RESPONSE</u>: Both interfaces are required. FirstDue is the provider of the current Fire Inspection solution, Firehouse is the current FRMS solution vendor and a solicitation for replacement of the FRMS solution is in development.

- Table 10 lists CodeRED for the mass notification interface. However, Attachment A5, CAD Interface Specifications, line IGen 26, lists Reverse911, Everbridge, and Red Alert as examples. Should we interface to CodeRED AND the other three, or are those just examples?
 <u>RESPONSE:</u> The current alerting solution is CodeRed, the other three listed are just examples.
 For items in the Eunctional Specification Workbooks marked with an importance
- For items in the Functional Specification Workbooks marked with an importance of "n/a," are responses required? <u>RESPONSE:</u> No, responses to items marked as n/a are not required.

All other provisions of the Solicitation Documents shall remain unchanged. This Addendum No. 2 is hereby made a part of the Solicitation Documents to the same extent as those provisions contained in the original documents and all itemized listings thereof.

Each Respondent is requested to acknowledge receipt of this Addendum No. 2 with the Proposal Forms.
