Payment in full of the outstanding balance will be due to Utilities thirty (30) days after the date of the invoice. A late payment fee of one and one-half percent (1.5%) per month shall be assessed to every past due customer/Payer account. An account is considered to be past due beginning thirty-one (31) days following the date of the invoice. Customer/Payer will be responsible for paying all charges associated with the performance of the Work, including late payment fees and all the expenses incurred in collecting any past due amount.
