

INCORPORATED COUNTY OF LOS ALAMOS RESOLUTION NO. 25-23

A RESOLUTION OF SUPPORT FOR THE ELECTRIC VEHICLE INFRASTRUCTURE PROJECT FUNDED BY THE NEW MEXICO DEPARTMENT OF TRANSPORTATION (CONTROL NO. HW2C0245010)

WHEREAS, the New Mexico Department of Transportation (“Department”) has awarded the Incorporated County of Los Alamos (“Grantee”) a capital appropriation in the amount of FOUR HUNDRED THIRTY-FIVE THOUSAND THREE HUNDRED EIGHTY-EIGHT DOLLARS (\$435,388.00) pursuant to Laws of 2024, Chapter 66, Section 33, Subsection 94, for the purpose of planning, designing, constructing, and equipping electric vehicle infrastructure at the Los Alamos County Mesa Public Library, located at 2400 Central Avenue, Los Alamos, New Mexico 87544; and

WHEREAS, the Grant Agreement (Control No. HW2C0245010) requires the Grantee to assume full responsibility for project implementation, ownership, maintenance, and operation of the infrastructure constructed with these funds; and

WHEREAS, Attachment A to the Grant Agreement requires the Grantee to adopt a formal resolution of support, including acceptance of liability and funding responsibilities associated with the project.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE INCORPORATED COUNTY OF LOS ALAMOS:

Section 1. Project Support: The Council of the Incorporated County of Los Alamos (“Council”) fully supports the Electric Vehicle Infrastructure Project as described in the Grant Agreement and commits to its timely and complete implementation.

Section 2. Ownership and Liability: The Incorporated County of Los Alamos (“Grantee”) accepts ownership of the infrastructure improvements constructed as part of the Project and assumes full liability for their use, operation, and maintenance upon completion.

Section 3. Maintenance and Funding: Grantee shall provide sufficient funding, personnel, and resources to maintain the improvements and related amenities for their useful life and for a period of at least ten (10) years as required by the Grant Agreement.

Section 4. Compliance: Grantee affirms its commitment to comply with all terms of the Grant Agreement, including applicable state and federal laws, reporting obligations, and fiscal management standards.

Section 5. The Incorporated County of Los Alamos Manager or their designee is hereby authorized to sign the Grant Agreement, Requests for Payment, and other documents necessary to fulfill Grantee’s obligations under the Grant Agreement.

Section 6. This Resolution shall take effect immediately upon its adoption.
