Addendum No. 2

This Addendum provides the following information as well as questions received and the County's answers to all potential Bidders:

- 1. Delete Sections 1.5.1 Bid Form and 1.5.2 Bid Alternate and Allowances in its entirety and replace with the attached updated Sections 1.5.1 and 1.5.2. Original Bid Form did not have a Total Base Bid Line.
- 2. Question: A strand has not been requested to support the 63860 feet of aerial fiber, and at the Pre-Bid Conference it was stated that non-shielded fiber will be needed for this application. In the past we have quoted self-support fiber with a messenger, however, if self-support fiber is not to be used, please clarify what the County is requesting, since no strand was requested in the RFP. Please provide the max span length, sag and loading calculations. We are also quoting wind dampers, that will be directly affixed to the fiber quoted, if no strand is present. Please clarify if this will be a change order or if it's an addendum that is on the IFB.

Response: Please refer to IFB24-35, Summary of Work, Page 9, #7: Two (2) wind dampers are required on each span. Also refer to Page 10, #9: Contractor shall provide a messenger wire at all spans over 650 feet. Contractor shall lash cable to messenger wire per fiber optic manufacturers recommended lashing.

All other provisions of the Solicitation Documents shall remain unchanged. This Addendum No. 2 is hereby made a part of the Solicitation Documents to the same extent as those provisions contained in the original documents and all itemized listings thereof.

Each Bidder is requested to acknowledge receipt of this Addendum No. 2 with the Bid Forms.
